

Sparsholt C of E Primary School is the Data Controller for the use of personal data in this privacy notice. The school collects, uses and is responsible for certain personal information about you.

When we do so we are regulated under the UK General Data Protection Regulation and we are responsible as 'controller' of that personal information for the purposes of those laws. Our Data Protection Officer is Mrs Kate Morey.

Why do we collect and use personal information?

We collect and use pupil information:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care and support services
- to assess the quality of our services and how well our school is doing
- for statistical forecasting and planning
- to comply with the law (including legal requirements to share data with the local authority and Department of Education)
- safeguarding children
- to keep children safe (food allergies or emergency contact details)
- to meet the statutory duties placed upon us by the Department for Education
- to ensure that we are able to contact parents and carers in the case of an emergency
- to ensure that our medical provision for individual pupils meets their specific requirements as stated on health care plans
- for effective communication with parents and carers
- to ensure that we have the correct permissions for the sharing of images of the pupil
- to ensure that we have the correct permissions for school trips, including local visits

The categories of personal information that we collect, hold and share include (this list is not exhaustive):

- personal identifiers and contacts (such as name, unique pupil number, address, contact details)
- characteristics (such as ethnicity, language, and free school meal/service child eligibility)
- attendance information (such as sessions attended, number of absences, absence reasons and any previous schools attended)
- assessment and attainment information (such as key stage and phonics results)
- safeguarding information (such as court orders and professional involvement)
- special educational needs (including the needs and ranking)
- medical and administration (such as doctors information, child health, dental health, allergies, medication and dietary requirements)
- behavioural information (including exclusions and any relevant alternative provision put in place)
- modes of travel
- trips and activities
- images of pupils (and occasionally other individuals) engaging in school activities
- post 16 learning information
- any information that has been raised as a parental or pastoral care concern
- information that will ensure the health, safety and wellObeing of pupils, such as Personal Emergency Evacuation Plans
- parenting and guardianship arrangements as imposed by the law

Legal Basis for processing

The UK General Data Protection Regulation allows us to collect and use pupil information with consent of the data subject, where we are complying with a legal requirement, where processing is necessary to protect the vital interests of a data subject or another person and where processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller. When the personal information is Special Category Information we may rely on processing being in the substantial public interest in addition to consent of the data subject and the vital interests of the data subject or another.

Our requirement for this data and our legal basis for processing this data where complying with a legal requirement includes the Education Act 1996, 2002 and 2011, The Children's Act 1989 and 2004, Education and Skills Act 2008, Schools Standards and Framework Act 1998 and the Equalities Act 2010.

Collecting personal information

Whilst the majority of personal information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the UK General Data Protection Regulation, we will inform you whether you are required to provide certain personal information to us or if you have a choice in this. Where we are using your personal information only on the basis of your consent you may ask us to stop processing this personal information at any time.

Storing personal data

We hold pupil data securely for the set amount of time shown in our retention schedule. For more information on our data retention schedule and how we keep your data safe please contact the school office.

Who do we share pupil information with?

We routinely share pupil information with:

- schools that the pupils attend after leaving us
- local authorities
- the Department for Education (DfE)
- our regulator Ofsted
- Arbor (the school's information management system)
- CPOMs (CPOMs Systems Ltd)
- Libresoft Librarian
- NHS school nursing team
- Tucasi SCO Lunch/Trips/Events payment system
- Hampshire Music Service
- Drift IT Services (IT /network support service)
- Netmedia parent evening booking system
- Tapestry early years learning journal
- eSchools our VLE and texting service supplier
- School trip suppliers (photo consent / medical conditions)
- Online apps which support the curriculum (e.g. TT Rockstars, Numbots, Nessy)
- Children's services, or other professional bodies, where the health, safety and wellbeing of a pupil may be a concern
- The Police, if requested as a result of a concern about a pupils' health, safety and wellbeing
- The pupil's own parents / carers

Why we share pupil information

We do not share **personal** information with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The Department may share pupils' personal data with certain third parties, including:

Organisations fighting or identifying crime may use their legal powers to contact DfE to request access to individual level information relevant to detecting that crime. Whilst numbers fluctuate slightly over time, DfE typically supplies data on around 600 pupils per year to the Home Office and roughly 1 per year to the Police.

Requesting access to your personal data

Under the UK General Data Protection Regulation, parents and pupils have the right to request access to information about them that we hold. You also have the right, subject to some limitations, to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed
- a right to seek redress, either through the ICO or through the courts
