Our aim is to ensure all pupils are inspired to be active, develop fundamental skills, and foster a lifelong love of sport.

Key Achievements in 2024/25

Outstanding Team Success

- **Lacrosse:**
Our lacrosse team achieved second place in the Southern Regional Pop Lacrosse Tournament and qualified for the Pop Lacrosse National Finals - an exceptional accomplishment, demonstrating teamwork and sporting excellence.
- **Football:**
The school football team won the Winchester District Final, showcasing not only their athletic ability but also their dedication and sportsmanship.
- **Netball:**
The netball team triumphed in the Winchester District competition, further highlighting the breadth and depth of talent nurtured at Sparsholt.

Whole-School Initiatives

- **Sparsholt Shooting Stars Award:**
Every child participated in this award scheme, celebrating all forms of physical activity both in and out of school. This initiative reinforced the value of an active lifestyle and recognised diverse sporting achievements.
- **The Daily Sparsholt Stride:**
All pupils engaged in our daily 'Sparsholt Stride' initiative, collectively completing at least 5km each week. This regular activity has boosted physical fitness and well-being across the school.

Increased Participation and Engagement

- **Extra-Curricular Clubs:**
There has been a notable increase in pupils joining after-school sports clubs, including cricket, lacrosse, rounders, and football. This growth reflects our inclusive approach and the broadening appeal of physical activity within our school community.

Impact of Sports Premium Funding

- **Raised Participation:**
The number of children regularly participating in sports and physical activity has increased, with every child accessing a minimum of 30 minutes of activity daily at school.
- **Improved Confidence and Wellbeing:**
Pupils report higher confidence and enjoyment in PE lessons and clubs, contributing to their overall well-being.
- **Enhanced Teamwork and Skills:**
Successes in team sports have promoted collaboration, resilience, and leadership among pupils.

- **Sustained Activity:**
Initiatives like the Sparsholt Stride and Shooting Stars Award have embedded a culture of daily physical activity.
- **Staff Development**
Staff have developed their skills in PE teaching through observation and collaboration with qualified coaches in football, multi-sports, and dance. This has enhanced lesson quality and staff confidence in delivering engaging PE sessions.

Next Steps

- Sustain and further develop inclusive sport and activity opportunities.
- Continue supporting school teams and broadening the range of sports on offer.
- Monitor and evaluate the impact on pupils' physical and emotional well-being.
